SUMMARY ACCEPTANCE FORM 2022/23

Magdalen students living in College Accommodation will already have signed a contract with the College, which includes among other things the *Information and Regulations for Members of the College*, as amended from time to time, which contains at Appendix F the text of the Accommodation Licence Agreement by which students and the College are bound. The *Information and Regulations for Members of the College* is available on the College's website at <http://www.magd.ox.ac.uk/internal-pages/>, and is also supplied in hard copy to all Members of College at the start of each academic year. In this way students are expected to have read the *Information and Regulations for Members of the College* (including the Accommodation Licence Agreement) prior to coming to the Porters' Lodge to collect the keys for their accommodation. They are required to sign this form to confirm that they have read these documents and accept the terms and conditions thereof.

**Licence Periods 2022/23 showing day of arrival and day of departure**

Undergraduates have a **Termly Licence to Occupy** for the eight weeks of each term. Additional accommodation is booked as Vacation Residence and charged by the day.

Hilary Term	All Undergraduates Thursday 12 <sup>th</sup> January – Sunday 12 <sup>th</sup> March 2023
Trinity Term	All Undergraduates Thursday 20 <sup>th</sup> April – Sunday 18 <sup>th</sup> June 2023

Graduates have a **9-Month Fixed Licence to Occupy**, which runs from 1<sup>st</sup> October 2022 to 30<sup>th</sup> June 2023, and are not required to vacate their rooms for the short vacations. However, Long Vacation Residence must be applied for if required.

**Keys to rooms will not be provided unless this Summary Acceptance Form is signed by the Student (the terms below are used in the Licence Agreement).**
