Your legacy gift

After making provision for your loved ones, we hope you will consider making a legacy gift to Magdalen. Provision can be made for a fixed sum of any size, a percentage of your estate, or the remainder of your estate once other bequests have been made.

Inheritance Tax relief

Charitable donations are not subject to UK Tax and may even reduce your overall Inheritance Tax rate if 10% or more of your estate is left to charity. This means that charitable legacies can cost your beneficiaries a fraction of the amount received by the charity.

If you wish to include Magdalen in your Will, you should indicate that your legacy benefits: Magdalen College, University of Oxford. Charity number 1142149.

The Society bears the name of Sir John Fastolf (1380-1459), a commander in the Hundred Years' War, whose philanthropy became a founding endowment for Magdalen.

Our recognition programme

Alongside the Fastolf Society, College also recognises donors at the following levels:
