

## MEDICAL ARRANGEMENTS

The College requires all students to be registered with a doctor in Oxford and to notify the College of the name of this doctor.

However, students with long-term or chronic conditions who wish to remain registered with their existing non-Oxford GPs may do so and will be treated, if required, by College or other Oxford doctors as temporary residents. While there may be a requirement for the “home” GP to disclose details of the long-term or chronic condition to better enable treatment of a non-related illness by the doctor with whom the temporary residency registration is held, such action will ensure that, in an emergency, or as otherwise required by the student, access to local medical treatment in Oxford will be available. Furthermore, if a student wishes to similarly register as a temporary resident with an Oxford doctor other than a College doctor under similar arrangements that will be entirely acceptable, provided that the College is aware of which doctor he or she is registered with.

The College Doctors, who are the Northgate Health Centre, 15 Market Street, Oxford, OX1 3EF (telephone 311500), have agreed to accept any member of the College as a patient.

To ensure satisfactory and informed medical care, if necessary, from the time you enter College, please complete your registration with the College Doctor (online at: [www.campusdoctor.co.uk/oxford](http://www.campusdoctor.co.uk/oxford)) as soon as possible and by 12 September 2025 at the very latest.

While you are at College, your Oxford address is regarded as your Home address for NHS purposes and you will find that this has been saved onto the form provided. The ‘last address’ should be your address at home, or at boarding school, i.e., where you would last have been registered for medical treatment.

You should remain registered with a doctor in Oxford during your time at the University, but can obtain treatment elsewhere in the United Kingdom as a temporary resident.

If you are registering with another doctor in Oxford, please tell the Admissions Officer ([admissions@magd.ox.ac.uk](mailto:admissions@magd.ox.ac.uk)) which GP Practice you are registered with.

NHS charges for drugs and dental care can be heavy. If you are on a low income you should consider applying for an exemption certificate: see <https://www.nhsbsa.nhs.uk/exemption-certificates>.

Fixed charges are made for dental treatment under the NHS but many dentists prefer to take patients privately and it can be difficult to find a dentist in Oxford willing to give NHS care. It is not advisable to arrive in Oxford in urgent need of dental treatment.
